If you have nominated for LEA and LE Chapter Awards within the past three years, please send in your completed EOI nomination form only, your CV Summary will be on record.

**Key Dates:** Jury Members are required to be available for jury briefings, review and deliberations during this time:

- Nomination Form & CV Summary - due before Friday, 16 August 2024.
- Jury Selection and Briefing (via email) – from Friday, 6 September and finalised before 20/9/24.
- First Jury Review – Friday 20/9/24 to Friday 11/10/24 (three weeks). Citations due Friday, 18 October 2024.
- Overall Jury Review (to judge the overall winner) if required – Friday 18/10/24 to Friday 1/11/24 (2 weeks). Citations due Wednesday, 16/11/24.
- Chapter Awards Announcement: will be dependant on each Chapter to confirm.

Until all Jury Expressions of Interest/Nominations and the number of entries received in each Category are reviewed, I am unable to guarantee an individual a position on a judging panel. Notification of selection will occur before 20/9/24. Please note – students and graduates are not eligible to participate on these jury panels.
